# Proposed Wellbeing and Sustainable Development (Scotland) Bill

#### Introduction

A proposal for a Member's Bill to ensure policy development and implementation by public bodies is in line with principles of sustainable development and wellbeing by introducing a duty for public bodies to promote these principles and establishing a Commissioner for sustainable development and wellbeing.

The consultation runs from 14 December 2022 to 24 March 2023

In North Ayrshire, the council is developing community links to LfS by funding and supporting schools with gardening projects. This has been hugely successful and the children, families and teachers have a much better understanding of sustainable education through this project.

The council is currently creating an activity STEM Trail for families and young children at Eglinton Park to promote wellbeing and sustainability. The STEM Team is also working with the Ayrshire Growth Deal to design and oversee a programme that promotes recycling and STEM activities at the beach park and create an Irvine Harbourside trail for the community.
