Proposed Wellbeing and Sustainable Development (Scotland) Bill

Introduction

A proposal for a Member's Bill to ensure policy development and implementation by public bodies is in line with principles of sustainable development and wellbeing by introducing a duty for public bodies to promote these principles and establishing a Commissioner for sustainable development and wellbeing.

The consultation runs from 14 December 2022 to 24 March 2023

This is a big and important topic, with lots of chat and discussion, but has been missing some leadership and some focus. We either believe this is an issue and reprioritise it and therefore redirect resources to it, Q1. Which of the following best expresses your view of the proposed Bill? or we accept we're having an unstructured and opportunistic approach, which appears to be what we've had so far. Having the muscle and the force of government policy behind this issue is an important stage in the development of wellbeing that is linked to sustainable and positive development. I believe we should get serious about this, have heavy involvement from third sector and communities as we can, and seek to minimise the bureaucracy that aften follows such measures. Bureaucrats do have a role, but not in the actual delivery or development, which is best left to those in an enterprising and subsidiarised community role.

I don't mind and would settle for whatever works best. The topic is too big to be slowed down, so I favour the quickest route to market for whatever services and processes are needed to make a substantive difference.
