# Proposed Wellbeing and Sustainable Development (Scotland) Bill

#### Introduction

A proposal for a Member's Bill to ensure policy development and implementation by public bodies is in line with principles of sustainable development and wellbeing by introducing a duty for public bodies to promote these principles and establishing a Commissioner for sustainable development and wellbeing.

The consultation runs from 14 December 2022 to 24 March 2023

Acting sustainably requires public bodies to routinely balance their decisions and consider the wide range of impacts of their actions. Understanding the different aspects of sustainable development is key, as different public bodies have different remits.

Over the past 3 years [REDACTED] has been focused on supporting [REDACTED] through the pandemic and then to shift to recovery from the pandemic. A number of existing workstreams were paused to allow for this focus. As the sector continues to recover, we have been working with the system to consider long-term planning, as well as understanding new ways of working of our staff, which will inform our operational model and allow us to identify opportunities for policy development as well as public service reform in the coming years.
