#### Introduction

A proposal for a Member's Bill to ensure policy development and implementation by public bodies is in line with principles of sustainable development and wellbeing by introducing a duty for public bodies to promote these principles and establishing a Commissioner for sustainable development and wellbeing.

RTPI Scotland support the laudable intentions of the proposed Bill but wish to see full considerations and alignment is made to legislative landscape of the planning system, with its critical role in delivering sustainable development and moving towards a well-being economy.

As set out in response to the previous question RTPI Scotland believe that the planning system is a critical means by which we can achieves sustainable development and move towards a well-being economy. The recently adopted National Planning Framework 4 is a clear example of this, with significant weighting given to the climate and biodiversity crisis. However, to enable the planning system to deliver the clear aspirations set out in the NPF4, over and the above the development of more legislation, a clear plan needs developed to provide the sufficient resources for the long-term.

RTPI Scotland recognise the need to legally to define sustainable development, however we also recognise the problems set out in the consultations of attempts to define sustainable development experienced elsewhere. The planning system itself is a good example of challenges around defining sustainable development. We note the definition used in the NPF4 is as follows:

Development that meets the needs of the present without compromising the ability of future generations to meet their own needs. (The Brundtland Definition. Our Common Future, The World Commission on Environment and Development, 1987).

If a definition of sustainable development were to be set out in a proposed Bill, RTPI Scotland would support the use of the above definition to provide a consistent and aligned approach.

In many regards in the NPF4 the approach to encouraging sustainable development has evolved to set out more specific criteria and expectations around what sustainable development should look like on the ground. This can be seen with, for example, a new policy around 20 minute neighbourhoods.
