# Proposed Wellbeing and Sustainable Development (Scotland) Bill

### Introduction

A proposal for a Member's Bill to ensure policy development and implementation by public bodies is in line with principles of sustainable development and wellbeing by introducing a duty for public bodies to promote these principles and establishing a Commissioner for sustainable development and wellbeing.

The consultation runs from 14 December 2022 to 24 March 2023

#### Please explain the reasons for your response.

I am clear that it is vital that all policy and legislation at all levels of government is checked against clear criteria to ensure that sustainable development guidance and well-being guidance is followed. This is in the public interest. I also believe that we have a responsibility to future generations which should be made clear. The bill will also enable the monitoring of these accountabilities.

# Please explain the reasons for your response, including any views on what the definition should include.

I agree with Sarah Boyack who states in the introduction to her proposed bill - 'It is my belief that establishing an overarching definition of sustainable development and ensuring public bodies undertake new duties, supported by the newly- established Commissioner, will ensure we avoid the future prospect of allowing policy to be made without due regard being given to the impact on our planet, our resources and future generations.'

While the definition of sustainable development is recognised as being a challenge (due to the significant differences in some definitions through time and geography) I am clear that it is essential to place the definition in the proposed bill to ensure that there is not confusion but clarity as to what the obligations and opportunities are.

The fusing of economic, social and environmental considerations is fundamental in this definition. The Brundtland definition is often referred back to. Well, there might be merit in this broad definition, I believe that it is important to refer to Scotland within the definition and also to set it firmly in the global context.

I do not think it is a copout not to try to produce a definition. At this stage. I believe that it is essential for there to be an inclusive and listening discussion leading to the development of a short, succinct and carefully crafted, Scottish definition which can be referred to for many years to come.

This will demand bravery not to be knocked off course and I wish those involved good luck!

In our hearts and minds, we all know what well-being is in terms of physical and mental health and the ability to have a quality of life – in economic and environmental terms. Perhaps social terms are harder to define however, in order to have well-being for the majority of the population we need to have a re-Balanced, economy and society with well-being at its heart.

Perhaps it is hard to know whether the definition of well-being should include how we get from where we are to where we need to be for there to be a more general sense of well-being for the population of Scotland? Again, I do not wish to give my definitive view on what the definition should be – this needs to be developed inclusively through this consultation and beyond in the lead up to stage one of the proposed bill.

I feel strongly that there should be a Commissioner whose key functions should be statutory. Model of governance – The commissioner should be appointed by the Scottish Parliament and the budget should be set by the parliament and agreed by the parliament.

I have noted in the past the concerns over there has not been enough funding for the Welsh commissioner to carry out duties effectively. It is essential that the Scottish sustainable development and well-being Commissioner is adequately funded with the funding to have a team around him or her in order to work effectively.

The commissioner should be able to play a role in strengthening existing duties, all legislation.

It is important that public bodies do not only promote, but adhere to these principles in policy dev and implementation. This should be clearly stated in the duties section of the proposed Bill. Many will argue that there could be a clash with other public duties but this should be at tte top of the hierarchy.

There are frequently alternative policies or decisions which can be taken which would adhere to the new duties- or road widening or a reopening of a rail line with affordable fares and a good timetable.
